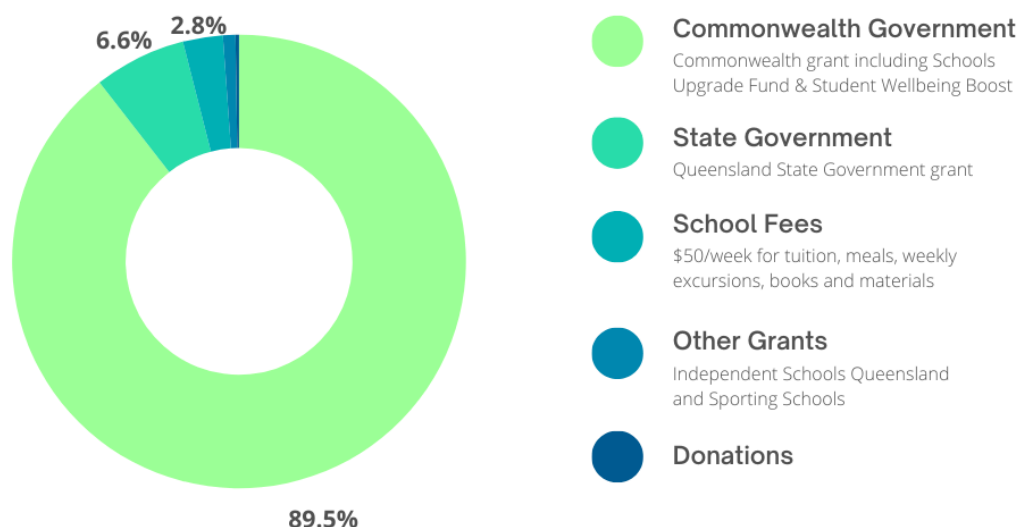

Teaching staff were retained and enrolments increased by 42% from 7 students in 2022 to 10 students in 2023. Responses in the school's annual opinion survey were positive.
